Renewal Home Occupation License	\$50	\$25 credit if under \$20,000 annual sales Plus \$5 per full-time employee over one Plus \$3 per each rental unit exceeding three \$500 maximum fee
Amusement Devices	\$30	Per unit
Temporary License	\$25	Plus \$1 per day up to 120 days for a maximum of \$125
Fireworks License	\$125	Per stand plus \$300 cash bond with a Liability Insurance to be not less than \$2,000,000/\$2,000,000 for bodily injury and /or property damage.

Commercial Site Plan	\$400	First acre, plus \$100/each additional acre up to \$1,000 maximum

Single Family Residential Site Plan	\$200	For homes that require Planning Commission or City Council review
Subdivision - New	\$200	Plus \$50/lot up to a maximum of \$1,000
Subdivision - Condominium to PUD	\$100	Plus \$25/lot up to a maximum of \$1,000
Subdivision - Vacation		
Lot Line Adjustment/Lot Combination	\$50	For adjustments that require Administrative Committee approval
	\$200	For adjustments that require Planning Commission/City Council approval
Zone Text Amendment	\$500	
Zone Map Amendment (Rezoning)	\$450	Plus \$100 per acre up to \$1,000 maximum
Conditional Use Permit (CUP)	\$50	For adjustments that require Administrative Committee approval
	\$250	For adjustments that require Planning Commission/City Council approval
Variance	\$50	For variances that require Administrative Committee review
Variance	\$250	For variances that require Planning Commission or City Council review
Appeal - of an administrative land-use determination	\$250	For items decided by the Planning Director
Appeal - Any and all other land-use decision appeals	\$250	Plus ½ the actual cost of the Administrative Law Judge (or other appeal authority) and the actual cost of public notice.

Notes:

All commercial and home occupation businesses, amusement device and beer/liquor licenses expire December 31st of each year and are to be renewed January 1st. A 50% penalty is charged against any license which has not been renewed by February 14. A 100% penalty is charged against any license which has not been renewed by April 1. Seasonal uses must receive Administrative Committee approval and then maintain a Commercial Business License each year of operation.
