



FREQUENTLY ASKED QUESTIONS 2024 SEASON

When and where is the Farmers Market?

- **Location:** Bountiful Town Square
- **Address:** 75 E 200 S Bountiful, UT
- **Dates:** Every Thursday June 20 - October 17
 - (excluding July 4 for Independence Day)
- **Hours:** 4pm - 8pm all season

How much does it cost to be a vendor?

There is no application fee. Bountiful City does not take a percentage of vendor sales. Booth fees vary per vendor type as follows:

- \$15 per week - Fresh Fruits & Vegetables Farmer
- \$20 per week - Merchandise / Crafts / Other
- \$25 per week - Food Items
- \$25 per week - Food Truck
- \$17 per week - Table Space (limited amount available)

Note: We no longer offer discounted rates for annual vendors

When can I apply?

Applications for vendors and musicians for the 2024 season will be available on the following dates:

- **Round 1: March 1, 2024 - March 31, 2024.**
 - After Round 1, the applications will temporarily close.
 - Round 1 applicants will receive a response during the first two weeks of April.
- **Round 2: April 15 - end of Farmers Market Season**
 - These late applications will be reviewed as market space and manager time allows.

I've been a vendor before, do I still have to apply?

Yes, you will still need to submit an application and wait for approval. If you sign-in with your vendor information from 2023, our online system should remember your information. Please make any required updates. We do not guarantee any rights-to-return as a previous vendor, but welcome you to apply to participate again.

What types of vendors are accepted?

The Bountiful Farmers Market prioritizes local farmers and vendors and follows the guidelines below for approving vendors:

- Utah-grown plants, fruits, & veggies
- Handmade crafts made by the vendor themselves
- Utah made or grown processed foods
- Prepared food vendors
- Non-profits, on occasion, as space permits and as applicable to the Market
- Other service vendors as applicable and as determined by the Market Manager

What types of vendors are NOT accepted?

The Bountiful Farmers Market DOES NOT accept the following:

- Commercial or imported items (limited exceptions)
- Franchises
- Non-owner operated businesses
- Out-of-state processing
- Promotional only vendors (unless part of a Market sponsorship)

Do I need a Business License?

All vendors who are residents of Bountiful and perform business outside of the Farmers Market as well as at the Farmers Market should have a business license through the city of Bountiful. Please fill out an application through the Bountiful City website, or contact the Bountiful City Planning Department at 801-298-6190 with questions.

Do food vendors need a special license?

- Approved food vendors will need to contact the Utah Department of Agriculture & Food and/or the County Health Department for approval of health department permits and/or UDAF registration to sell food at a farmers market.
- **All Farmers** should refer to producesafety.utah.gov for information and support on safe food handling for Farmers Markets, as well as a helpful resource.

What if my application is denied, or put on the waitlist?

If your application is **denied**, you may not meet our vendor qualifications. If you are put on our **waitlist**, there may already be a similar product at the market, or we are full for the dates you applied for. However, occasionally spaces open up. On this occasion, market managers refer to the waitlist for vendors to fill those spaces. This sometimes happens the week-of a market! You will be contacted via email if a space becomes available for you, so keep an eye on your email during the market season.

Can my child apply to be a vendor?

Vendors must be a minimum of 18 years old. However, we allow a limited number of youth vendors, who may operate a booth but must be supervised by an adult.

Is there access to power and WiFi at the market?

- Yes there is access to electrical outlets throughout Bountiful Town Square, but please indicate your need for access to power on your application so you can be assigned a location near one of the power boxes.
- No, there is no wifi access at the Bountiful Town Square. You must use personal hotspot or other resources for any internet needs.

I'm a musician, can I play at the Farmers Market?

Applications for musicians wishing to perform at the Farmers Market will also be available beginning March 1 on our website. There is no application fee, and no compensation for performing. There are two time-slots available each week:

- 4 - 6 PM : set-up at an assigned space within the market. Intended for solo performers or small groups. Power for amplification is available, but sound levels must be appropriate and quieter for being near vendors and guests.
- 6 - 8 PM : set up on mainstage.

Musicians are not required to play their entire set-time. Music must be family-friendly with no explicit lyrics.

Is there SNAP at the market?

SNAP is typically provided by a few individual vendors at our market. We will provide a list of participating vendors here when the season begins.
