



2021 Watering Restrictions for Bountiful City Culinary Water Users

THESE RESTRICTIONS APPLY **ONLY** TO BOUNTIFUL RESIDENTS
WHO USE CULINARY WATER FOR IRRIGATION PURPOSES

These restrictions **do not** apply to Bountiful residents who receive irrigation service from Bountiful Water Subconservancy District (aka BWSD, Bountiful Irrigation), Deuel Creek Irrigation or South Davis Water District

On June 22, 2021, the Bountiful City Council passed Resolution 2021-13 in response to the severe drought conditions in Utah. The ordinance restricts water use and imposes penalties for not observing the restrictions for each home/property that utilizes Bountiful City culinary water for irrigation, and allows outside watering according to regulations listed below:

- A maximum of three (3) watering cycles per week are permitted (see below).
- Watering is permitted **ONLY** during the hours of 6:00 p.m. - 10:00 a.m.
- Individual zone (valve) run times are limited to 20 minutes for spray heads, and 40 minutes for rotor heads.

In addition, residents are required to observe the following weekly watering schedule:

- Homes with **even** numbered addresses are permitted to water their lawns on Monday, Thursday, and Saturday.
- Homes with **odd** numbered addresses are permitted to water their lawns on Tuesday, Friday, and Sunday.
- **Watering is NOT permitted** on Wednesdays to allow culinary water reservoirs to refill.

Violations regarding the weekly watering schedule and the regulations outlined above, will result in the following penalties and enforcement actions:

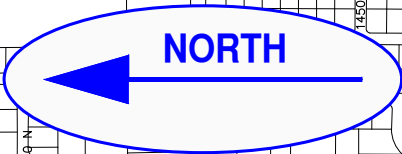
- **First offense:** Resident is issued a written warning.
- **Second offense:** Resident is issued a \$100 fine which will be added to their utility bill. The fine can be waived if a third-party irrigation analysis is completed, and the resident signs an agreement to comply with watering restrictions
- **Third offense:** Resident is issued a \$250 fine added to the utility bill and another third-party irrigation analysis must be completed. The resident must also sign an agreement to comply with watering restrictions.
- **Fourth offense:** Resident is issued a \$500 fine added to the utility bill and the resident's irrigation (outside) water will be disconnected for the remainder of the irrigating season.
- **Fifth offense:** Resident's culinary water service will be turned off for the remainder of the irrigating season.
