## NEW COMMERCIAL BOND FORM

It is understood that the following requirements will be met before occupancy will be granted at:

1. All cuts and/or fills are to be graded at a maximum 2:1 slope.
2. If item 1 cannot be accomplished, a retaining wall or walls must be constructed at owner's expense.
3. A separate Building Permit is required for retaining wall construction. All retaining walls 4' and over in height must be engineered adequately for structure and stability. The design of same is to be reviewed by the City Engineer before construction begins. Please refer to (Retaining Wall Requirements) for details.
4. The structure is **NOT** to be inhabited until the above-stated items have been complied with.

## CURB, GUTTER & SIDEWALK BOND

*Bountiful City Code Chapter 4, Title V, Section 102*

1. The bond posted with the building permit will be returned after an inspection by Bountiful City no sooner than after occupancy is granted and landscaping has been completed. **The cash bond will be returned to:**

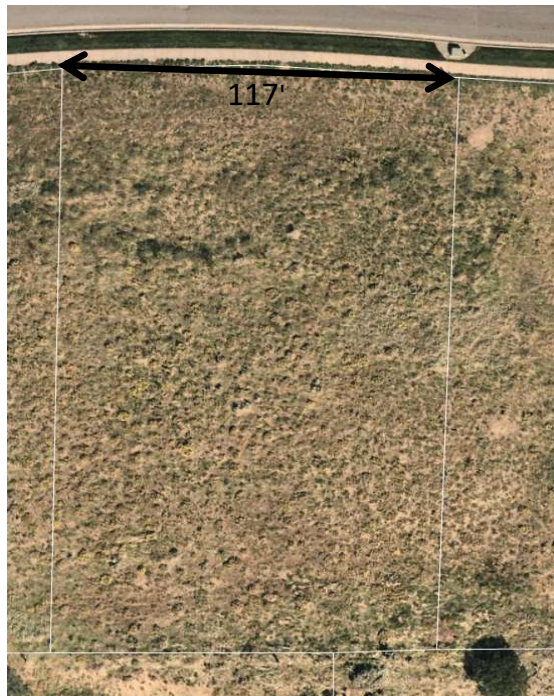
